Power of Attorney

This Power of Attorney ("Agreement") is granted this _____ day of _____, 20_____, by and between Delaware Depository Service Company, LLC ("DDSC") of Wilmington, Delaware and

_____ ("Customer") (together, the "Parties"). Whereas, Customer wishes to facilitate his/her ability to buy, sell, deliver, transfer, trade, liquidate, pledge or segregate precious metals and other assets ("Assets") held with DDSC; and whereas Customer warrants that he/she is of legal age and mentally competent, the Parties agree as follows:

- 1. Agent Powers:** Customer appoints _____ ("Agent") as his/her attorney-in-fact to act as his/her Agent to deposit precious metal into Customer's Assets account; to direct DDSC to buy, sell, deliver, transfer, trade, liquidate, pledge or segregate Assets in this account; to execute any necessary documents to accomplish any of these authorized acts; and to issue instructions to DDSC, written or by electronic means.

DDSC is authorized to, and is requested to accept and honor, without limit as to amount and without further inquiry, such instructions to deposit or transfer Assets by written or electronic means, when drawn, made, signed, issued or endorsed by the Agent named herein, whether tendered in payment of the individual obligation or deposited to the personal account of such Agent, or otherwise. Notwithstanding any other provisions of this Agreement to the contrary, Customer will indemnify and hold DDSC harmless from any and all liabilities, damages, losses, expenses, claims, demands, suits, fines or judgments, including but not limited to, costs and attorney's fees Customer or DDSC may incur as a result of DDSC's compliance with the instructions of any Agent named herein as authorized to act on Customer's behalf. The authority of the Agent named herein shall continue until revoked by Customer but DDSC shall be fully protected in acting on such authority and shall not be charged with any notice of the revocation of such authority or the removal of any such Agent unless and until it shall have actually received an amendment to this Agreement setting forth such revocation or removal.

- 2. Additional Terms:** This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware. Customer agrees that the jurisdiction and venue of any cause of action by Customer against DDSC arising from this Agreement shall lie exclusively with State or Federal Courts in Delaware.

This Agreement contains the entire understanding between the Parties and may not be changed or modified except by a written agreement signed by the Parties. This is a durable power of attorney and its effectiveness shall be unimpaired by any subsequent disability of Customer.

This Agreement may be cancelled by either party by giving written notice to the other. This Agreement is executed solely for the benefit of Parties and not for the benefit of any other person.
